## ASHP Advantage Launches National Initiative on Risk Evaluation and Mitigation Strategies in Health Systems

**BETHESDA, MD, February 3, 2011** –ASHP Advantage has launched an initiative to educate hospital-based physicians and pharmacists about existing risk evaluation and mitigation strategies (REMS) for medications administered in a hospital or components of a health system. This initiative is designed to prepare physicians and pharmacists for REMS provisions required by the FDA and explain their implications for health care professionals.

Since the law that authorized REMS went into effect in March of 2008, the number and complexity of REMS have increased significantly. There are currently over 150 medications that require REMS by the FDA. Physicians, pharmacists, and other health care professionals are responsible for understanding specific requirements of approved REMS programs and ensuring the successful implementation of REMS to facilitate the intended goals of improving medication safety while allowing patients' access to the medications necessary to treat their medical conditions.

The initiative, featured at [www.remsupdates.org](http://www.remsupdates.org), was developed by a multidisciplinary steering committee comprised of pharmacists and a physician with expertise in REMS and is conducted in partnership with the Society of Hospital Medicine and supported by an educational grant from Astellas Pharma Global Development, Inc.

An online learning portal features links to a variety of educational activities including live, interactive webinars accredited for continuing education for pharmacists and physicians. Visitors to the Web portal will be able to access on demand a web-based home study activity, register for regional educational symposia, and access REMS resources including podcasts, e-Newsletters, an online discussion guide, and other essential links. In addition, participants can use a "Talk to Us" feature to submit questions and share the impact of how REMS is impacting practice in health systems.
